#### **Message from the Executive Director**

The change of the season from winter to spring and now summer, brings us hope for longer days, warmer weather, and more sunshine. But 'as the seasons change so do we; may we be aware we are shifting just like the wind."

#### Volunteers are Needed

#### Safe Ride / Bartending Program:

The MRWSA Safe Ride / Bartending Program provides these services to community events such as weddings and company parties (Christmas, staff appreciation, etc.) for a fee. This may be a safe ride or a bartending event or both for an event. This program raises up to \$10,000 per year which assists the Mountain Rose Centre to provide a variety of services. MRWSA has special insurance to provide coverage for any volunteer involved in these volunteer opportunities.

#### Safe Ríde Program

Volunteers use their personal vehicle to provide safe transport from the event to where the guest(s) is staying within a 15 kilometer distance of Rocky Mountain House. The time commitment is 3 hours usually from 10 pm to 1 am but this fluctuates. Mileage can be reimbursed to the driver. Any cash tips received from the guests are donations to MRWSA.

#### Bartending Program

Volunteers support events by completing the bar service. One volunteer per event must have ProServe. The time commitment is 6 to 8 hours usually from 6 pm to 1 am but this fluctuates. Any cash tips received from the guests are donations to MRWSA.

COVID-19 continues to cause a significant reduction in fundraised dollars due to the increased competition for charitable donations as non-profits try to address increased costs from implementing safety during COVID-19. # Canadian Benefit for Parents of Young Victims of Crime

The death or disappearance of a child is devastating. It can leave parents grief stricken and unable to work. Federal income support is available for parents coping with the death or disappearance of a child as a result of a probable criminal offence and who suffer a loss of income when they take time away from work to cope with this tragedy.

#### BENEFIT AMOUNT AND DURATION

You may be eligible to receive \$450 per week, before tax, every two weeks. You may receive up to 35 weeks of income support during the two-year period immediately following the incident. The benefit is considered taxable income. Income tax will be deducted from your benefit amount, and you will receive a statement of income slip for income tax purposes at the end of the year. The benefit can be shared between multiple eligible parents.

#### **ELIGIBILITY**

To receive the Canadian Benefit for Parents of Young Victims of Crime, applicant(s) and the incident must meet the following criteria:

#### APPLICANT ELIGIBILITY CRITERIA

You must

- be legally responsible for the child or children involved in the incident;
- have recent labour force attachment, having earned at least \$6,500 in the previous calendar year or in the 52 weeks prior to the incident;
- be on leave from employment or working no more than 50 percent of your regular work week, up to a maximum of 20 hours per week;
- · have a valid Social Insurance Number;
- not have been charged with committing a probable Criminal Code offence that led to the death or disappearance of the child; and
- not be receiving any type of Employment Insurance benefits or Québec Parental Insurance Plan (QPIP) benefits

#### INCIDENT ELIGIBILITY CRITERIA

- The child must be deceased or missing as a result of a probable Criminal Code offence;
- The child must have been under 25 years old at the time of the incident;
- · The incident must have occurred in Canada;
- In the case of a missing child, the child must have been missing for over a week; and
- In the case of a deceased child, where the child is 14 years of age or older, it must be improbable that the child was a willing party to the crime that led to their death.

#### APPLYING

You can apply online or by mail using the Canadian Benefit for Parents of Young Victims of Crime Application Form at canada.ca/parents-young-victims-crime. The following two forms must also be completed and sent with your application:

Employment Form – must be completed and signed by the employer that you are currently working for or that you worked for in the 52 weeks before the incident occurred. If you are self-employed or are reporting both self-employed and employment earnings, you must also submit your Canada Revenue Agency notice of assessment from the previous income tax year.

Incident Report Form – must be completed and stamped by the law enforcement agency where the incident was reported.

#### **Family Support Services**



The Family Support Program has enjoyed hosting several Enrichment Activities throughout the spring, focusing on providing a supported environment where moms and their children, both in Emergency Shelter, Second Stage Housing, as well as having moved into safe and stable housing in the community, can enjoy time together as a family; connecting, reconnecting, and repairing relationships that have been stained by the stress of domestic violence in the family's past. Throughout the spring we hosted an Easter Themed Scavenger Hunt for Families, we planted both flowers as well as a variety of fruit and vegetables in several garden boxes that we have been able to install on Mountain Rose Centre property, as well as the garden boxes we once again rented at the Community Garden this season. The community families we support continue to participate in the Collective Kitchen Program in collaboration with Mountain Rose Center's Housing Program in the Food Security/Stability Program. It is a pleasure to provide a variety of nutritious groceries to families and hear stories and see pictures of the family spending time making a variety of meals together!

Just recently we added an additional team member to our team with the addition of a second child minding worker for the summer months! We are excited for the increase possibilities this holds for summer programming, both on and off property!

#### What Are the Causes of Addiction?

There is no single cause of addiction; <u>people begin using substances for many reasons</u> and one person's path to addiction may look drastically different from that of another.

Apart from the case of beginning drug use via a prescription from a doctor, there are 4 main reasons people may try substances:

- To feel good. Drugs may lure people with the appeal of:
  - A euphoric high.
  - Feelings of power.
  - Increased confidence.
  - o Energy.
  - Relaxation.
- To feel better. Someone with anxiety, high stress, or depression might turn to drugs to try and manage distressing symptoms.
- To do better. Some drugs have the reputation of improving athletic or academic performance, so people may see them as a way of getting ahead or even just keeping up.
- To fit in or experiment. People, adolescents especially, may use out of sheer curiosity or to try and impress their peers.

#### What Are the Signs of Addiction?

#### Physical changes, such as:

- Drastic weight loss or gain.
- Changes in appearance and/or hygiene.
- Dilated or constricted pupils.
- Red eyes.
- Slurred speech/problems with motor coordination.

#### Psychological changes, such as:

- Increasing anger, irritability, and aggression.
- Rapid mood changes.
- Odd and bizarre thoughts, e.g., being extremely paranoid for no reason.
- Loss of motivation.
- Hallucinations seeing, hearing, feeling, smelling, or tasting things that are not present.

#### Social changes, such as:

- Spending more time with a new group of friends.
- Increased conflict or isolation from previous support system.
- Lying and secretiveness.
- Sudden involvement in criminal activity.
